Guidelines for extended abstract

Cover Letter

It should provide the following information:

- **Title:** Provide a concise and informative title that reflects your paper's main topic and findings.
- **Author details:** Mention the full names of all authors and their institutional affiliation/s with address, official email IDs, and contact details.

Manuscript without author/s identifiers

- **Keywords:** Include 3-5 keywords that are relevant to the paper's content.
- **Introduction:** Provide an outline of the context of your research, and emphasise any research or practice gaps. Clearly state the research questions you aim to address and discuss the significance of your research. Explain why the topic is relevant and how it contributes to the existing body of knowledge.
- **Literature review:** Present a brief evidence-based synthesis of the extant literature to situate the gaps you propose to address.
- **Methodology:** Provide a brief description of the research context and the methods or approaches used in your study. This should include details on the research design, data collection methods, and analytical techniques. Make sure that the methodology section is concise but sufficiently informative for readers to understand how the research was conducted.
- **Results:** Depending on the stage of your research, summarise the key findings or elaborate/explain the expected outcomes. If required, use tables, graphs, or images to present your findings clearly and effectively, clearly mentioning the source.
- **Discussion:** Based on how you address your research questions, discuss what new knowledge or perspectives your research brings. Particularly, highlight any new insights or unexpected outcomes. Also, explain how the findings contribute to the field and their practical or theoretical implications.

- **Conclusion and limitations:** Provide a summary of the research study and discuss any limitations to suggest areas for further investigation.

Submission requirements

The extended abstract should be 2000 to 2500 words and submitted in the word document format, using A4 paper size. Please follow the formatting guidelines below:

- **Margins:** 1 inch on all sides
- **Font:** Times New Roman, Size: 12
- **Line spacing:** Double spacing
- **Originality of Work:** Please note that the author/s is/are responsible for ensuring the originality of the submitted work. We request that you check the same on Turnitin or some equivalent software. Once the submission is made, we will assume that the work is original. Any issue or dispute arising on account of plagiarism in content/concept shall be the sole responsibility of the author/s. We also suggest that AI-generated content should not be submitted.

- **References:** All references must follow the APA 6th edition style. Refer to the example mentioned based on categories:
